RE: Anest Iwata WS-400 Spray Gun

Mr. Hebbeler,

The Maricopa County Air Quality Department (department) has completed the review of the documents you have submitted requesting the use of the ANEST IWATA WS-400 Spray gun within Maricopa County. At this time, the department is conditionally approving the use of the ANEST IWATA WS-400 Spray gun within the jurisdiction of this department. This approval is limited to the application of coatings subject to Maricopa County Air Pollution Control Regulation III, Rule 345, Vehicle and Mobile Equipment Coating (revision date of 04/21/1999).


This approval is subject to the following conditions:

1. ANEST IWATA must supply written notification with each ANEST IWATA WS-400 spray gun sold or distributed for use within the jurisdiction of the department that the spray gun is ONLY approved for the application of coatings subject to Maricopa County Air Pollution Control Regulation III, Rule 345, Vehicle and Mobile Equipment Coating.
2. ANEST IWATA must supply written notification with each ANEST IWATA WS-400 spray gun sold or distributed for use within the jurisdiction of the department that the maximum air pressure supplied to the spray gun must not exceed 29 psig.
3. ANEST IWATA must supply an ANEST IWATA AK-1B air flow control valve and pressure gauge (Product Number 8130) or AK-1R air flow regulator and pressure gauge (Product Number 8131) with each ANEST IWATA WS-400 spray gun sold or distributed for use within the jurisdiction of the department.
4. ANEST IWATA must supply written notification with each ANEST IWATA WS-400 spray gun sold or distributed for use within the jurisdiction of the department specifying that the ANEST IWATA AK-1B air flow control valve and pressure gauge (Product Number 8130) or AK-1R air flow regulator and pressure gauge (Product Number 8131) must be properly attached to the spray gun and be in good working condition whenever the spray gun is in operation for coatings subject to Maricopa County Air Pollution Control Regulation III, Rule 345.
5. This approval is only valid if during actual operation, the ANEST IWATA WS-400 is equipped and operated with ANEST IWATA AK-1B air flow control valve and pressure gauge (Product Number 8130) or AK-1R air flow regulator and pressure gauge (Product Number 8131).

6. ANEST Iwata shall add a clearly visible permanent label specifying that the inlet air pressure shall not exceed 29 psig to all ANEST IWATA WS-400 spray guns sold or distributed for use within the jurisdiction of the department.
7. This approval is only valid if during actual operation the ANEST IWATA WS-400 spray guns are labeled as described above.

This conditional approval is only valid for the ANEST IWATA WS-400 spray gun, air flow control valve(s) and pressure gauge(s) listed in the above; used as described above; and in accordance with Maricopa County Air Pollution Control Regulation III, Rule 345, revision date of 04/21/99. Any modification of the spray gun, pressure gauge design or air flow control valve will invalidate this approval unless the modification is first approved by the Maricopa County Air Quality Department.
