RE: Approval of the W400-LV Spray Gun under Rule 4612

Dear Mr. Tomita:

The San Joaquin Valley Air Pollution Control District (District) has received your request for approval to sell the W400-LV spray gun within the jurisdiction of the District. We have reviewed the test results you submitted to the South Coast Air Quality Management District and their approval of this spray gun. Based on this review, we have determined that the W400-LV spray gun is approved for use under District Rule 4612, Motor Vehicle and Mobile Equipment Coating Operations, pursuant to Section 5.8.4. This approval is subject to the following conditions, consistent with the South Coast AQMD's approval:

1. ANEST IWATA shall supply written notification with each W400-LV spray gun sold or distributed for use within the jurisdiction of the San Joaquin Valley Air Pollution Control District that the spray gun is only approved for the application of coatings subject to Rule 4612.
2. This approval is only valid if the air pressure supplied to the W400-LV spray gun is equal to or less than 20 psig. ANEST IWATA shall supply written notification with each W400-LV spray gun sold or distributed for use within the jurisdiction of the San Joaquin Valley Air Pollution Control District that the maximum air pressure supplied to the spray gun shall not exceed 20 psig.
3. ANEST IWATA shall supply an ANEST IWATA AK-1B air flow control valve and pressure gage (Item #8130) or AK-1R air flow regulator and pressure gage (Item #8131) to clearly identify the maximum allowable spray gun inlet air pressure with each W400-LV spray gun sold or distributed for use within the jurisdiction of the San Joaquin Valley Air Pollution Control District. ANEST IWATA shall supply written notification with each W400-LV spray gun sold or distributed for use within the jurisdiction of the San Joaquin Valley Air

Pollution Control District that the ANEST IWATA AK-1B air flow control valve and pressure gage (Item #8130) or AK-1R air flow regulator and pressure gage (Item #8131) shall be properly attached to the spray gun and be in good working condition whenever the spray gun is in operation.

4. This approval is only valid if during actual operation the W400-LV spray gun is equipped with a properly operating ANEST IWATA AK-1B air flow control valve and pressure gage (Item #8130) or AK-1R air flow regulator and pressure gage (Item #8131).
5. This approval is only valid for the W400-LV spray gun model tested.
