Subject: Amended approval of ANEST IWATA W400-LV High Transfer Efficiency Spray

Gun

Dear Mr. Hebbeler:

Per your request, this letter serves as an amended approval for use of the W400-LV High Transfer Efficiency spray gun in Santa Barbara County. This equipment may be used in accordance with APCD Rule 339.D.7.e. Please note that conditions 6 and 7of this approval differ from the terms of the South Coast Air Quality Management District's February 26, 2009 approval letter.

The APCD's approval is based on the following conditions:

- 1. ANEST IWATA shall supply written notification with each W400-LV spray gun sold or distributed for use within the jurisdiction of the Santa Barbara County Air Pollution Control District that the spray gun is only approved for the application of coatings subject to Rule 339.
- 2. This approval is only valid if the air pressure supplied to the W400-LV spray gun is equal to or less than 20 psig. ANEST IWATA shall supply written notification with each W400-L V spray gun sold or distributed for use within the jurisdiction of the Santa Barbara County Air Pollution Control District that the maximum air pressure supplied to the spray gun shall not exceed 20 psig.
- 3. ANEST IWATA shall supply an ANEST IWATA AK-1 B air flow control valve and pressure gage (Item #8130) or AK-1 R air flow regulator and pressure gage (Item #8131) to clearly identify the maximum allowable spray gun inlet air pressure with each W400-LV spray gun sold or distributed for use within the jurisdiction of the Santa Barbara County Air Pollution Control District. ANEST IWATA shall supply written notification with each W400-LV spray gun sold or distributed for use within the jurisdiction of the Santa Barbara County Air Pollution Control District that the ANEST IWATA AK-1 B air flow control valve and pressure gage (Item #8130) or AK-1 R air flow regulator and pressure gage (Item #8131) shall be properly attached to the spray gun and be in good working condition whenever the spray gun is in operation.

- 4. This approval is only valid if during actual operation the W400-LV spray gun is equipped with a properly operating ANEST IWATA AK-1B air flow control valve and pressure gage (Item #8130) or AK-1R air flow regulator and pressure gage (Item #8131).
- 5. This approval is only valid for the W400-LV spray gun model tested.
- 6. ANEST IWATA shall maintain a list of all auto body shops to which the W400-LVspray guns were sold to for use in Santa Barbara County that includes the following:
  - Name of person to which spray gun was sold
  - Company name
  - · Business address
  - Number of W400-LV units sold to this entity

ANEST IWATA shall provide to the Santa Barbara County Air Pollution Control District (Attn: Inspection Supervisor) a copy of this list no later than March 1<sup>st</sup> of every year, which provides the above information for all units sold during the previous calendar year.

7. This approval is revocable by the Santa Barbara County Air Pollution Control District at any time.
